After growing up in Northern Michigan's community of Traverse City, Scot Zimmerman worked as an Investment Banker for Kidder Peabody & Co, and Dresdner Bank AG, in New York City. A desire to return to the Midwest took him to Detroit, Michigan, where he worked in International Finance for Comerica Bank, with duties involving managing an emerging market bond portfolio, and acting as Country Officer for India, South Korea, and Australia. A growing family motivated a move back to Northern Michigan with Old Kent Bank, where Scot acted as Community President for the North Central Michigan marketplace. Upon combination with 5/3 Bank, Scot worked in various leadership roles in the Northern Michigan Commercial Banking group based in Traverse City. His acquisition of American Instrument and Implant, a medical manufacturing company, took Scot out of banking for seven years, before he rejoined the industry as a part of a turnaround team hired to resolve regulatory problems at Northwestern Bank, and create salable value. Scot joined Chemical Bank with its acquisition of Northwestern Bank in 2014 and was named Senior Lender. He then became Community President of the Traverse City Community Bank in 2015, and Regional President in 2016, when he also joined the Senior Leadership Team. Chemical Bank's combinations with Talmer Bank, TCF Bank, and Huntington Bank continued to require Scot's leadership in the North.

Scot Zimmerman acquired Melges 24 hull number 034 in 2015, to sail with his daughter, wife, and friends. In 2017 hull number 717 was acquired. Over the past six and a half years Scot and team have sailed (2) Worlds, (3) Canadian Nationals, (4) US Nationals, (1) North American, (1) Gold Cup, multiple other travel regattas, and the annual summer series in Northern Michigan. Venues sailed have consisted of: Lake Geneva, Wisconsin, Muskegon, Michigan, Harbor Springs Michigan, Lake Saint Clair, Michigan, Charleston, South Carolina, Fairhope, Alabama, St. Petersburg, Florida, Miami, Florida, Key West, Florida, and Toronto, Ontario.

Scot joined the USMCA Board when the Secretary position came open mid-term. After this he was elected by the membership to continue in the role. In addition to these duties, he serves as Fleet Captain for the local Melges 24 fleet which has grown from four boats to fifteen boats over the last half dozen years. In 2019, Scot organized North Americans in Traverse City, Michigan, an event that pulled in 48 entrants. He also has taken a leading role in organizing the Quantum Great Lakes Cup Series in 2021 and 2022.
